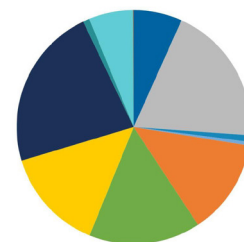

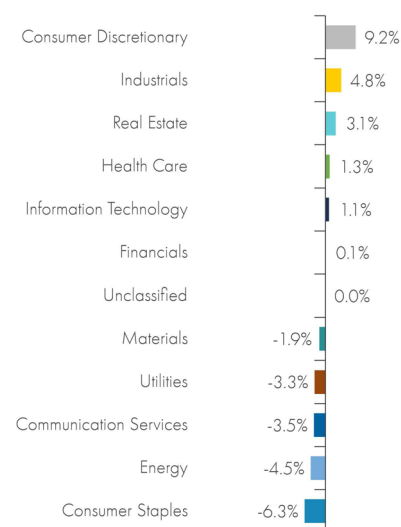

Risks
