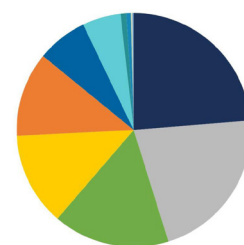

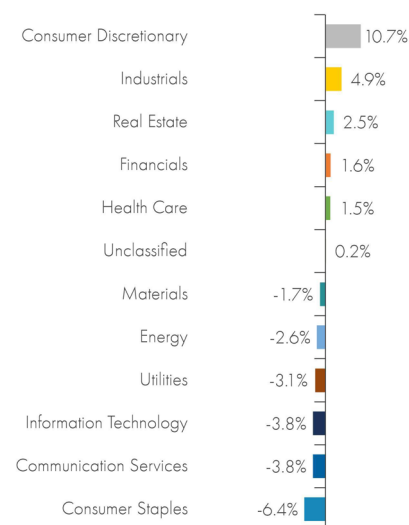

## Risks
