





Baron Discovery Fund's annualized returns for the Institutional Shares as of June 30, 2019: 1-year, 5.57%; 3-year, 24.04%; 5-year, 12.05%; Since Inception (09/30/2013), 15.46%. Annual expense ratio for the Institutional Shares as of September 30, 2018 was 1.12%, but the net annual expense ratio was 1.10% (net of the Adviser's fee waivers).

Baron Small Cap Fund's annualized returns for the Institutional Shares as of June 30, 2019: 1-year, 9.59%; 3-year, 18.21%; 5-year, 9.89%; 10-year, 14.79%; Since Inception (9/30/1997), 10.36%. Annual expense ratio for the Institutional Shares as of September 30, 2018 was 1.04%.

Baron Growth Fund's annualized returns for the Institutional Shares as of June 30, 2019: 1-year, 14.51%; 3-year, 18.28%; 5-year, 11.31%; 10-year, 15.52%; Since Inception (12/31/1994), 13.40%. Annual expense ratio for the Institutional Shares as of September 30, 2018 was 1.03%.

Because of its long-term approach, the Fund could have a significant percentage of its assets invested in securities that have appreciated beyond their market capitalization at the time of the Fund's initial investment.

Alpha measures the difference between a fund's actual returns and its expected performance, given its level of risk as measured by beta. **Beta** measures a fund's sensitivity to market movements. The beta of the market is 1.00 by definition. **Upside Capture** explains how well a fund performs in time periods where the benchmark's returns are greater than zero. **Downside Capture** measures how well a fund performs in time periods where the benchmark's returns are less than zero. **Standard Deviation** (Std. Dev) measures the degree to which a fund's performance has varied from its average performance over a particular time period. The greater the standard deviation, the greater a fund's volatility (risk). **Active Share** is a term used to describe the share of a portfolio's holdings that differ from that portfolio's benchmark index. It is calculated by comparing the weight of each holding in the Fund to that holding's weight in the benchmark. Positions with either a positive or negative weighting versus the benchmark have Active Share. An Active Share of 100% implies zero overlap with the benchmark. Active Share was introduced in 2006 in a study by Yale academics, M. Cremers and A. Petajisto, as a measure of active portfolio management.
